FOR ALLOTTEES WHO HAVE NOT YET TAKEN OVER POSSESSION

1. All the allottees of Towers A to I, P & Q (Package-I) of Greater Mohali Project are hereby informed that the DLP of Package-I is expiring on **31 Dec 16**. The allottees are requested to take over their flats immediately and definitely before 31 Dec 16 and also forward the defects if any before the expiry of DLP period. Defects which are not notified to the contractor within the currency of DLP cannot be rectified. 3. A number of allottees who have taken over their flats have kept their DUs locked and repairs could not be carried out. If allottees do not make the premises available for rectification of defects, AFNHB will not be responsible for defect rectification work beyond 31 Dec 16. It is important to note that only the defects which are notified in the register kept at the site for this purpose will be treated as defects notified within the DLP period. No other method of defect reporting will be considered.
