(d) Casting of votes by allottees	- 15 Nov 20 (0700 hrs to 1700 hrs)
(e) Counting of votes	- 16 Nov 20 (1000 hrs onwards)
(f) Declaration of result	- 16 Nov 20 (1600 hrs).
4. It is intimated that complete electoral process shall be conducted through virtual mode i.e. email only. Members / allottees have to mark their choice in the ballot paper against the names of contender for each posts. Thereafter, the signed and scanned ballot paper is to be forwarded to AFNHB HQ through email. Accordingly, counting of votes will be carried out.
